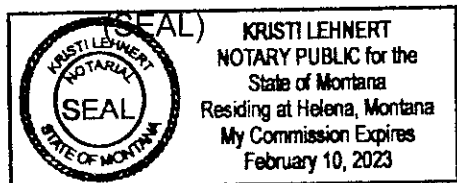

Statement of facts:

I am filing this complaint against Wilmot Collins on the basis that he has not complied with the finance reporting practices specified by the Commissioner of Political Practices (COPP) concerning C5 Reports and his C1A.

Mr. Collins registered with COPP on 3/31/21, yet he did not file a C5 report until 06/28/21 - a clear violation of the reporting practices.

Once he registered on 03/31/21, he was obligated to submit a C5 report starting with April 20th. He did not. He continued to disregard his obligation to report in May, as well and when he finally got around to submitting a report in June, it was EXTREMELY tardy, as it was not submitted until 06/28/21. Therefore, the public was not privy to his campaign spending and contributions until 3 months after he registered with COPP.

Which brings me to my second point. Although his registration was submitted to COPP on 03/31/21, his first and extremely tardy C5 in June indicates that he was actually spending/receiving campaign funds as of 03/01/21 - a FULL 30 Days before he registered with COPP.

Mr. Collins has clearly demonstrated a complete disregard and lack of respect for the most basic of rules, which govern the financial actions/transactions of candidates here in Montana; rules which are in place to keep candidate spending and contributions transparent to the public in real time - not three or four months later.

As it is the Commissioner of Political Practices duty and responsibility to promote confidence, transparency, and accountability in Montana's democratic processes, I respectfully request that Commissioner Mangan look into these violations which are clearly documented within Mr. Collins own registration and finance forms submitted to COPP.

Please see the attached articles relating to this subject that support the validity of this complaint.

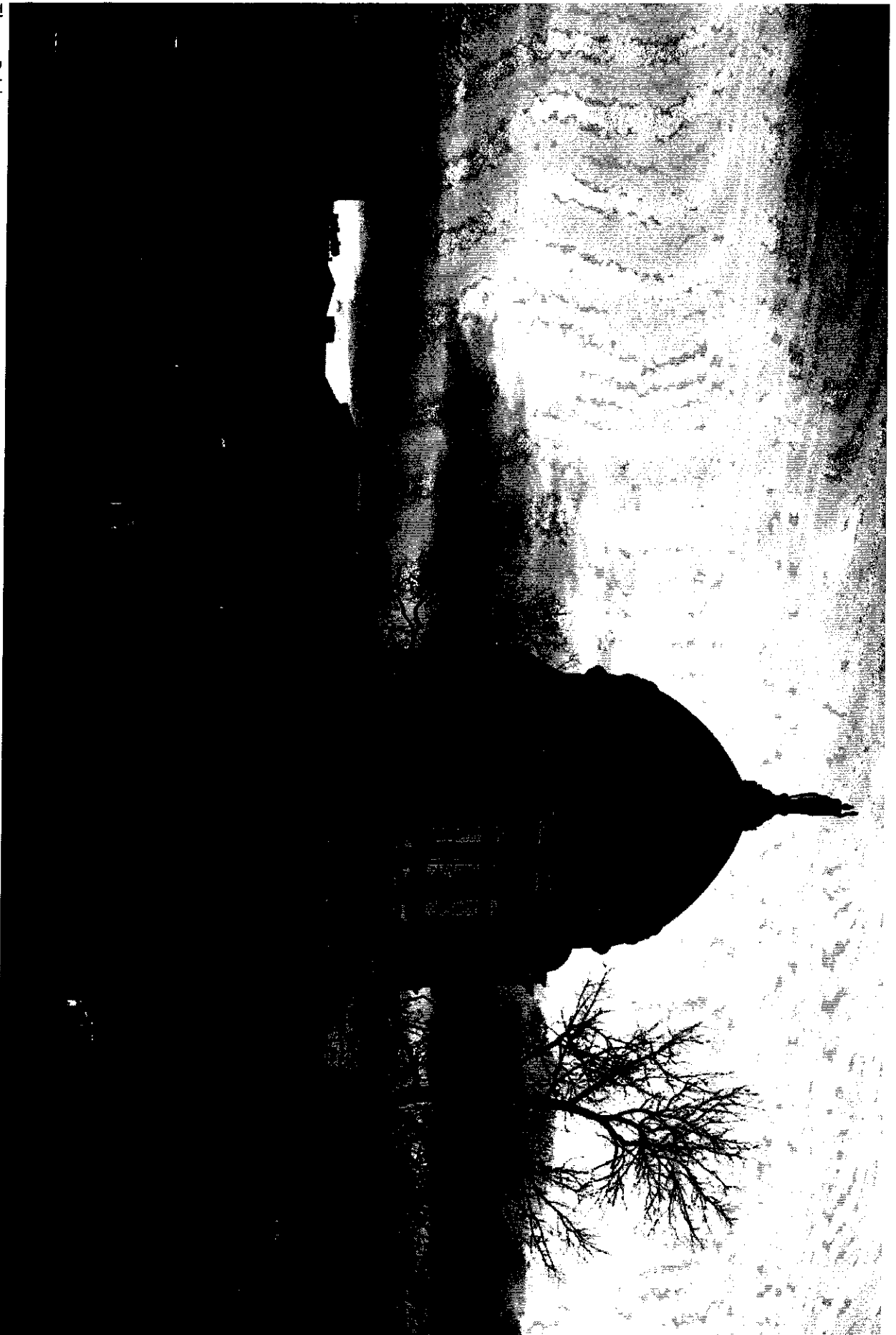

Disqualified Cascade candidate says had trouble filing

HELENA – A Libertarian candidate booted from the election for not filing all his paperwork on time said he asked the state to reconsider, but a state official said the decision stands.

Ron Vandevender, 59, a Cascade resident who filed to run for House District 80, was among the seven candidates disqualified for not filing business disclosure statements.

Vandevender blamed his bad luck on trouble with electronic filing, some by him and some by the state, saying he made several attempts to file. He said there were some instances in which he had a typo in the email address, but corrected it and still had trouble filing.

And he said there were errors with the state's filing system.

The others were four GOP hopefuls who were disqualified as House candidates: Richard Fife II, Michael Bruner and Suzann Nordwick, all of Butte, and Berthold Stumberg of East Helena.

Libertarian Senate candidate Carol Kent of Missoula and Democrat House candidate Riley Wisler of Billings also were removed.

The business disclosure statement, known as D1, was to be turned in within five days of filing.

Jeff Mangan, the state commissioner of political practices, notified Secretary of State Corey Stapleton Monday of the delinquent filers.

Vandevender, who has run for other state offices in the past, including governor in 2012, said there should be some recourse in which he could appeal the decision.

“People get mixed up and think politicians are not human and are super human ...” Vandevender said. “Everyone wants a politician that makes Jesus Christ look like a hoodlum and that is just not going to happen.”

He said he was in contact with the political practices office regarding his filing troubles.

Mangan said Wednesday there is no process for appeal, adding the state had met its deadlines and Vandevender was no longer on the ballot.

“There is nothing we can do,” he said.

Now running in the HD 80 seat are GOP incumbent Becky Beard and Democrat Catherine Scott.

Vandevender, a garlic farmer, said he resides in a remote area and was dealing with issues, such as weather, that prevented him from filing earlier.

“I live in the middle of nowhere on a ball of ice,” he said. “You have to survive.”

He said if nothing good comes out of this, he hopes to get the state’s electronic filing system straightened out.

Vandevender said he is checking out the possibility of running as an Independent, which would give him a later filing date.

He said he would not challenge the state in court.

“I do not see anything to gain from that aspect,” Vandevender said.

He said he may try to work through the Legislature to get rules changed and establish an appeals process.

The Secretary of State’s office reported last week that 389 candidates filed for the elections. The primary is June 5 and the general election is Nov. 6.
