Alden,

I am writing regarding the above-named matter, a formal Campaign Finance and Practices (CFP) Complaint received and accepted by the COPP. On August 29, 2022, COPP, via email, provided you a copy of the complaint, as well as a letter from Commissioner Mangan requesting a written response to the complaint from yourself. COPP requested this response be provided no later than Tuesday, September 6, 2022. As of today (September 12, 2022), COPP has not been provided with such a written response.

To fully evaluate the specific issues identified, COPP requires you provide a written response to this Complaint. As part of this response, COPP would request copies of receipts, invoices, or similar documentation detailing all campaign materials purchased through vendor Signs Now Helena; documentation detailing payment/s made or obligation/s owed to Signs Now Helena for campaign purchases; and copies of any correspondence made or received by your campaign concerning payments made or obligations owed to Signs Now Helena.

As a reminder, any response you provide will be made public on the COPP's website. Per Senate Bill 130, enacted by the 2021 Montana Legislature, any response you provide "must be posted on the commissioner's website".
