The Hi-Line Women's Coalition is a group formed in Havre, MT with the intention of engaging in "political activity and lobbying" according to their social media posts where they actively solicit donations for their various activities. A copy of that post is attached.

Recently the group purchased 54 radio ad spots on three local radio stations KPQX, KOJM and KRYK supporting the election of Paul Tuss, a candidate for Montana House District 28. A copy of the Issue Advertisement Agreement forms for each station is attached.

The group's activities appear to constitute a political committee as defined in 13–1–101 MCA and the purchase of radio ads supporting Paul Tuss would constitute an election communication subject to reporting under the Control of Campaign Practices section of the Montana Codes Annotated.

Hi-Line Women's Coalition has failed to register and report its election expenditures supporting a candidate for legislative office in violation of Montana political practices statutes.
