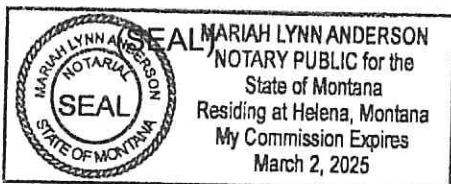

Dear Mr. Commissioner,

I would like to file this complaint against Curt Dallas of Helena, MT for sign attribution. Mr. Dallas has attribution on his signs, but according to ARM 44.11.601, all election materials are required by MCA 13-35-225 to clearly and conspicuously include appropriate attribution language. Although he has the attribution, it is not clear or conspicuous on any of his signs and does not include all the required information on the larger signs. Also, some of the frames on his larger signs cover the attribution completely. The list of signs is as follows: 40 Yard signs, 3 single-sided 32x48, and 9 two-sided 32x48.

This information is from his C-5 filed on 3/14/2022.

Attached are examples of the signs I've photographed in the Helena area.

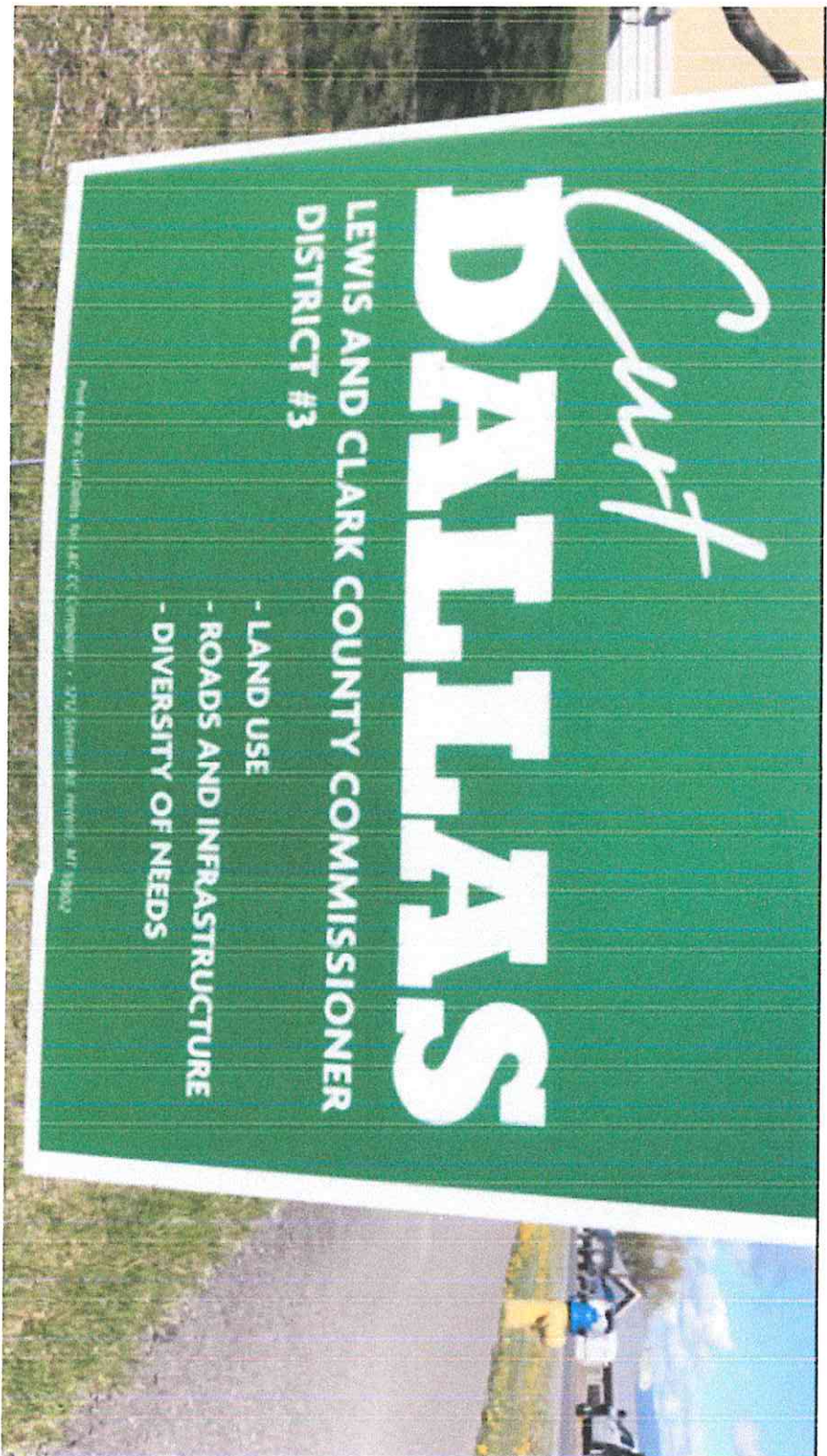
