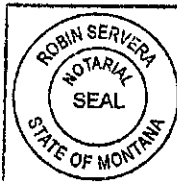

The latest finance reports for legislative candidates was due on March 21st ~~at 5pm~~ at 5pm MDT. Part of that finance report must have included that the candidate paid their filing fee. The COPP even sent an email to all candidates on March 16th (see attachment 1) saying "All candidates have at least paid their filing fee to the Secretary of State. That is part of finance reporting. This report DOES NEED to be done for the secretary of state to put your name on the ballot!" As of 9am on March 22nd Mary Caferro has filed a report that claims she has \$0 in donations and \$0 in expenditures. That is clearly inaccurate because she at least paid the money for her filing fee. MA13-37 states that candidates must file reports with contributions and expenditures. Mary Caferro has not reported any expenditures (see attachment 2) which is incorrect. She should have at least reported her filing fee.
