The Great Falls Republicans PAC has received an illegal contribution in the amount of \$1,627.50 from Steve Gist. The contribution from Steve Gist consists of surplus campaign funds. Attached is a copy of Steve Gist's C-5. Under Section 13-37-240, MCA, surplus campaign funds may not be donated to another campaign. In addition, under ARM 44.11.702(7), a candidate may not donate surplus campaign funds to a political committee. The Great Falls Republican PAC is a political committee.

Since the Great Falls Republicans PAC has received a contribution in violation of Chapter 37 of Title 13 of the Montana Code, the Great Falls Republicans PAC should be fined up to three times the amount of the unlawful contribution under Section 13-37-128(2), MCA. You also take into consideration that the people running this PAC have experience on other campaigns and should know Montana campaign finance law. Thus, there is no excuse for this illegal conduct and the Great Falls Republican PAC should be fined to the maximum amount under the law.
