Dear Commissioner Mangan,

First, we want to thank Mr. Brekke, the complainant, for filing the complaint and alerting us to this missing and pivotal step. We are a new organization and the failure to report was very much our error, we sincerely apologize. It was certainly not done with malice or wish to skirt any rules or regulations.

We will quickly rectify this error, by filing the required C-2 statement and registering as an Incidental Political Committee with the Commission of Political Practices. We are also filing our contribution report through the CERS. As our radio ad is our only expenditure made for the purpose of supporting or opposing 2022 non-federal Montana candidate/s or ballot issue/s, we have provided a copy of that receipt (as already provided in the original complaint) as well as a copy of the political donation by means of a written check.

Although our organization's sole purpose and mission is not one of political endorsement or campaigning- as evidenced that it represents at this time less than 10% of our overall budget and less than 25% of our organization's focus- we do recognize the importance of financial accountability when engaged in the political process.

We wish to thank the complainant again for bringing this issue to our attention and the Commission of Political Practices for giving us the opportunity to rectify the issue.





The Hi-Line Women's Coalition is a group formed in Havre, MT with the intention of engaging in "political activity and lobbying" according to their social media posts where they actively solicit donations for their various activities. A copy of that post is attached.

Recently the group purchased 54 radio ad spots on three local radio stations KPQX, KOJM and KRYK supporting the election of Paul Tuss, a candidate for Montana House District 28. A copy of the Issue Advertisement Agreement forms for each station is attached.

The group's activities appear to constitute a political committee as defined in 13-1-101 MCA and the purchase of radio ads supporting Paul Tuss would constitute an election communication subject to reporting under the Control of Campaign Practices section of the Montana Codes Annotated.

Hi-Line Women's Coalition has failed to register and report its election expenditures supporting a candidate for legislative office in violation of Montana political practices statutes.






