- 1)According to MCA 13-37-226 KEY should have filed a campaign report within 20 days of the election dated May 2,2011. They have failed to do so. A phone call to Political Practices on 12/8/2011 confirmed that there in no report on file.
- 2) Regarding the campaign report dated 6-24-2010 to 4-19-11, according to MCA 13-37-230 there must be addresses listed for the expenditures made. None of the expenditures has any addresses listed.
- 3) Regarding the campaign report dated 6-24-2010 to 4-19-11, according to MCA 13-37-230 there must be explanations for the expenditures made. Two items have no explanations.
- 4) Regarding the report dated 1-1-10 5-23-10, a contribution was accepted from Great Falls Sand and Gravel also doing business as Great Falls Redi Mix. This is an incorporated business (1804 4th Ave NW, 406-761-5400). This information was obtained by calling the bookkeeper of the business on 12-13-2011. According to MCA 13-35-227 contributions from corporations are prohibited.
- 5)According to MCA 13-37-229 the full name of each person who has made a contribution must be listed. In the report dated 6-24-10 4-19-11, there are three names of couples listed together and it is impossible to tell who has donated what amount. In the report dated 1-1-08- 5-17-08, there is one couple listed together.
