### Statement of Facts

As of today, December 9, 2016, the Missoula County Republican Central Committee has failed to file any C6 report since July 27, 2016, in violation of the reporting requirements provided for in MCA 13-37-226.

On March 9, 2016, the Missoula County Republican Central Committee filed a C6 report for the period January 1 – March 4, 2016 which lists \$20,316.19 in receipts for the period but provides no information about the source of this income, in violation of the provisions of MCA 13-37-229.

On July 11, 2016, the Missoula County Republican Central Committee filed a C6 report for the period March 5 – July 4, 2016 which lists no expenditures of any kind, including contributions to candidates, even though numerous candidates (e.g. Brad Tschida, David Moore, Michael Ellsworth, and others) reported receiving such contributions in the corresponding period. No contributions to candidates were reported on the C6 covering the following period ending on July 27, or in any other period, in apparent violation of the provisions of MCA 13-37-229.

## Commissioner Motl;

I write to file a formal complaint alleging violations of MCA 13-37-226 by the Missoula County Republican Central Committee by failing to file any of the C6 reports required in that section for any period after July 27 of this year. I further allege that the Missoula County Republican Central Committee violated MCA 13-37-229 by (a) failing to provide, in its March 9, 2016 C6 report the information required in that section regarding sources of income for the January 1 to March 4 period and (b) failing to list, in its July 11, 2016 and August 2 C6 reports, any contributions made to local candidates, even though numerous local Republican candidates reported having received such contributions on their C5s during the corresponding periods.

I ask the Commissioner's office to investigate this matter and bring a resolution to the political party committee in violation of the law.
