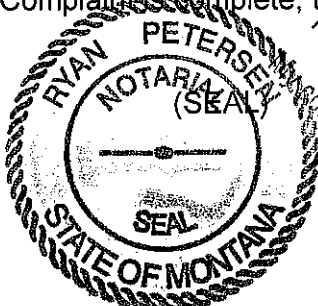

Statement of facts:

A. I believe candidate Robert T. Fanning has violated the following Montana Code Annotated statutes:

13-37-208. Treasurer to keep records. (1) (b).

13-37-215. Petty cash funds allowed. (1) (a) and (2).

13-37-225. Reports of contributions and expenditures required.

13-37-226. Time for filing reports.

13-37-230. Disclosure of expenditures made.

B. I allege candidate Robert T. Fanning is guilty of these violations:

1. Not keeping his campaign account current as required by 13-37-208.

2. Reimbursing himself for personal expenses not approved by 13-37-215.

3. Not properly filing reports as required by 13-37-225.

4. Not filing campaign reports on time as required by 13-37-226.

5. Not properly disclosing expenditures as required by 13-37-230.

C. Evidence:

1. Your records show the candidate has not met the requirements of 13-37-208, 13-37-225, and 13-37-226.

2. While I served as Fanning's campaign manager, I noted the candidate's reported expenses through December 31 of \$6,142 was significantly higher than my estimate. I suspect the candidate paid himself more than the legal or ethical amount. Below is my email of January 23, 2012, where I challenged this large expense and the reply by Fanning. Fanning refused to disclose his campaign expense accounting to Chuck Baldwin or me. He refused to join our scheduled conference call on January 24 to discuss his expense accounting. I resigned as campaign manager on January 25.

3. Below is a copy of my invoice to the candidate for campaign expenses I paid for the campaign. It says NO PAYMENT DUE. Fanning was supposed to report this as my personal \$1000 donation to his campaign.

2. Bob did not file Schedule A, which is normally done. I believe he must file Schedule A in order to protect us. Frankly, I am concerned about the details of how our expenses were calculated. How did we possibly make \$6,142 in expenditures? I have a feeling when the details are revealed we will look very bad and it will kill any possibility of getting future donations.

3. It is one thing that I am contributing all of my time to supporting our campaign. It is quite another that I may be risking being involved in or connected to a Campaign Finance violation investigation. I cannot afford this risk!

Discussion:

1. What is the "Unknown" expense on 12/08/2011 in the amount of \$1950.00? This is the large personal expense I suspected in Exhibit A. Even "Uptown Cafe" is identified.
2. There are 2 "All Serve Tire" expenses totaling \$895.50. Is Fanning buying new tires for his truck from his campaign account?
3. **Western Drug** expense in the amount of \$54.31. Is Fanning buying his medication from his campaign account?
4. "**Park Elect Corp**" expense of \$245.49. Is Fanning paying his electric bill from his campaign funds?
6. The "unknown" on 12/12/2011 in the amount of \$995.22 is the reimbursement to me for campaign expenses I paid in November. See Exhibit D.
