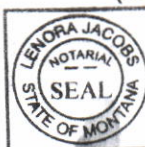

Statute violated: Montana Codes Annotated 13-35-226

4/13/15 It was brought to my attention that on 4/13/2015, elementary teachers were giving false, negative information on me as a candidate for trustee in District #23, or for Target Range School. This incident occurred at 3:15 p.m. on April 13, 2015 while the teacher was on the time clock and within the school building.

Several other community members say they or their children (as parents of students) were told that if Gary Botchek is elected, he will discontinue out of district students without tuition and the school will close.

The administration was advised of this violation on April 14, 2015. False information has leaked into the voting community which originated by teachers, on school time within the school building.

The report of the incident at 3:15 p.m. on April 13, 2015 was made by a former School Board member who served six years, part of the service was as Board Chair. While picking up a grandchild she was given false information, and advised the teacher it was not true.

Parents are so filled with these false statements that it took her 45 minutes to convince her daughter that the school's statement was not true. Several other community members or their voting age children were aware of the school's effort to spread this non-truth.
