

SETTLEMENT OF

COPP v. Montana Pro-Life Coalition and Dr. Annie Bukacek.

First Judicial District Court, Lewis & Clark County, No. ADV-2016-213

The parties to this settlement agreement are the Montana Pro-Life Coalition and Dr. Annie Bukacek, and the Office of the Commissioner of Political Practices, through the current Commissioner, Jeffrey A. Mangan. Each party and its representative makes a settlement declaration and then agrees to settle as follows:

**DECLARATION OF DR. ANNIE BUKACEK
and THE MONTANA PRO-LIFE COALITION**

Per. Mont. Code Ann. § 1-6-105, the undersigned declares under oath as follows:

1. I am Dr. Annie Bukacek. I live and practice medicine in Kalispell, Montana.
2. I am the current President of the Montana Pro-Life Coalition.
3. I offer this statement or Declaration to set out information and facts personally known to me. If I were called to testify under oath, I would testify consistently with the matters contained herein.
4. I have reviewed a certain letter dated May 16, 2012 supporting Dr. Rollan Roberts and opposing Sen. Bruce Tutvedt. A copy of that letter is attached to this statement (COPPvMPLC 001-3, 5). I have the following to say about this letter:
 - a. I did not write the words set out in the letter.
 - b. I did not sign the letter, provide a signature model for the letter or authorize anyone to add my name on the letter.
 - c. I did not discuss with or authorize any person or entity to prepare the letter and mail it out under my name.
 - d. The letter was mailed without my permission and without my knowledge and without the knowledge or permission of the Montana Pro-Life Coalition.

- e. My signature replication on the letter was made by a person or entity using a signature model of my name acquired without my knowledge or permission.
5. Neither I or the Montana Pro-Life Coalition authorized, prepared, approved, signed, ratified or distributed the mailer. Neither I or the Montana Pro-Life Coalition made an expenditure which is reportable under the campaign finance laws of the state of Montana in support of Dr. Roberts or in opposition to former Sen. Tutvedt in Montana's 2012 election cycle. My activities consisted of volunteer work and writing letters to the editor.
6. I did submit a letter to the editor of the Daily Inter Lake Newspaper which was published on May 6, 2012. A copy of that letter is attached to this statement (BUKACEK 0179).
7. I also submitted a letter to the editor of the Daily Inter Lake Newspaper which was published on January 17, 2016. A copy of that letter is attached to this statement (COPPV MPLC 015).
8. Nothing contained in Paragraphs 1 through 7 of my Declaration shall constitute an acceptance of, or agreement with, any of the assertions contained in the Declaration of Jeffrey Mangan, aside from those that restate assertions contained in Paragraphs 1 through 7 of my Declaration.

I declare under the penalty of perjury that the foregoing is true and correct.

**DECLARATION OF
JEFFREY MANGAN, COMMISSIONER OF POLITICAL PRACTICES
for the OFFICE OF THE COMMISSIONER OF POLITICAL PRACTICES**

Per. Mont. Code Ann. § 1-6-105, the undersigned declares under oath as follows:

1. I am Jeffrey Mangan, the Commissioner of Political Practices for the State of Montana. I make this declaration in response to the declaration of Dr. Annie Bukacek and the Montana Pro-Life Coalition.
2. I have read the declaration of Dr. Annie Bukacek and the Montana Pro-Life Coalition and reviewed the materials and statements produced in the enforcement action in this matter on which the declaration is based.
3. On January 14, 2016, Commissioner Motl found: “[t]he Commissioner notes that the MPLC letter has the appearance (type face, style of writing, pre-cancelled Banner bulk mail stamp) of a letter prepared, printed and mailed by the ‘corporate group’ of entities working with or through the Right to Work corporate entities. The Commissioner reserves a determination that other corporate entities could also be responsible for sufficiency decisions applied solely to MPLC.” (*Tutvedt v. Roberts, et. al.*, COPP-2012-CFP-047; *Welch v. Western Tradition Partnership*, COPP-2014-CFP-015; and *Welch v. National Right to Work*, COPP-2014-CFP-016, “Sufficiency Decision”, pp. 20-21).
4. Based on information and evidence in the COPP’s possession the letter dated May 16, 2012 (COPPvMPLC001-3, 5) was produced by Christian LeFer and/or Allison LeFer utilizing information gathered through their association with the National Right To Work Committee and their associated corporations and entities in the 2008 and 2010 election cycles.
5. The May 16, 2012 letter mailed under the Montana Pro-Life Coalition letterhead was written in the same style and tone as the letters from the National Pro-Life Alliance in the 2010 election cycle, and the letters from the Montana Committee to Protect the Unborn in the 2008 election cycle (funded by the National Pro-Life Alliance).
6. The costs of the May 16, 2012 letter in the 2012 Senate District 3 primary are completely unreported and undisclosed to the people of Montana. Further, the entity or individuals who mailed the letter failed to disclose the source of the funding for the mailer. The letter is visible election material, sent to the homes of voters, and meets the definition of “dark money” election activity.
7. I also find that the third party use of Montana Pro-Life Coalition’s name, president’s signature, and reputation without the authorization, approval,



ratification of the Montana Pro-Life Coalition to be reprehensible and fraudulent action taken by the third parties in the 2012 election cycle.

8. On behalf of the COPP, I adopt and ratify Commissioner Motl's determination in the Sufficiency Decision, "[t]he Commissioner reserves a determination that other corporate entities could also be responsible for sufficiency decisions applied solely to MPLC".
9. On behalf of the COPP, the declaration of Dr. Annie Bukacek and the Montana Pro-Life Coalition, the declaration is accepted as complete and any claim against Dr. Annie Bukacek and the Montana Pro-Life Coalition is resolved without fine, rebuke or finding of wrongdoing as to the May 16, 2012 letter (COPPvMPLC001-3.5).

I declare under the penalty of perjury that the foregoing is true and correct.

SETTLEMENT AGREEMENT


Based on the foregoing declarations and in contemplation of settling the matter of *COPP v. Montana Pro-Life Coalition and Dr. Annie Bukacek*, Cause No. ADV-2016-213, First Judicial District Court, Lewis and Clark County, the parties settle this matter as follows:

1. I, Dr. Annie Bukacek, agree to the dismissal with prejudice of all claims and counterclaims in this matter.
2. I, Dr. Annie Bukacek, as President of the Montana Pro-Life Coalition, agree to the dismissal with prejudice of all claims and counterclaims in this matter.
3. I, Jeffery Mangan, Commissioner of Political Practices, and for the Office of the Commissioner of Political Practices for the State of Montana, agree to the dismissal with prejudice of all claims and counterclaims in this matter.
4. That the COPP will move the Court for a stipulated order dismissing all the claims and counterclaims with prejudice, each party to bear their own attorneys fees and costs, in this matter.
