13-35-207. Deceptive election practices

On 2/19/16 I registered for the Montana Conservation Voters Campaign school 2/26-28 in Bozeman. Online payment of \$35 fee to MCV to attend. I have attached email correspondance. There is no indication of any other fee.

On Sunday 2/28/16, just as the class was ending early afternoon, MCV employee Shelbe Dantic told participants that we would need to fill out our COPP filings showing an in-kind donation from the PAC employees that were present that weekend.

I do not want to take any PAC funds, and had no prior notice that attending this event meant reporting such.

In a communication from Clayton Elliot, ED of MCV:

"That leaves us two choices moving forward, either your campaign can pay for the full cost of the training which is \$225.84 (your \$35 of previous contribution will go towards that), or you will be listed on our PAC's reporting filing as a candidate that we gave an in-kind contribution towards in the way of candidate training,

I did not solicit a campaign contribution from any PAC, and I don't believe a PAC can force one on me. I believed I was paying my own way.

I will not use money that my campaign supporters have entrusted with me to pay off the four PACs involved.
