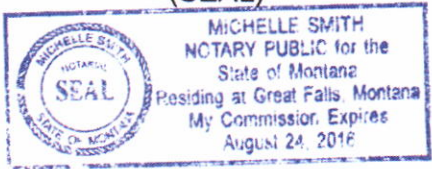

The candidates for the Vaughn-Cascade County Water and Sewer District, Kay L. Neil, Sean Beach, or Nancy L. Ackerson, or perhaps Leo Baer acting on their behalf, have violated M.C.A. 13-35-225(1) by having the enclosed poster and attached flyers printed and posted at various locations in Vaughn, including the Valley Country Store, the Glacier Gateway Conoco, Teton Bank, and the U.S. Post Office. The poster is an "election communication" because it is a printed material that expressly supports the candidacy of Kay L. Neil, Sean Beach, and Nancy L. Ackerson by urging voters to "remember to vote for" these candidates and touting their virtues. M.C.A. 13-1-101(14)(A)(v). The poster violates M.C.A. 13-35-225 because it does not "clearly and conspicuously include the attribution 'paid for by' followed by the name and address of the person who made or financed the expenditure for the communication." It is believed that Kay L. Neil may have financed the posters. Leo Baer also posted the poster at the Teton Bank. Due to their apparent involvement, a complaint is also being made against the following individuals:
