Dear Commissioner Motl:

I am writing to file another complaint against JC Kantorowicz for more violations of Montana campaign finances and practices laws. This complaint pertains to Mr. Kantorowicz's May 3, 2016 report and the Montana Christian Journal.

First, Mr. Kantorowicz has failed to file his reports electronically as required by § 13-37-226, MCA and ARM 44.11.302.

Second, Mr. Kantorowicz has failed to report in-kind contributions from the Cascade County Republican Central Committee related to the March 22, 2016 and April 27, 2016 candidate forums. Attached to this complaint is an email from George Paul stating the costs of the forum would be credited as an in-kind contribution. As I understand it, Sheridan Buck has reported a cost as an-kind contribution. The failure to disclose the in-kind amounts is a violation of § 13-37-229, MCA.

Third, Mr. Kantorowicz has violated Montana law by failing to file a C-1 form with your office within five days of making an expenditure. Montana law requires a candidate to file a C-1 form within five days of receiving a contribution or making an expenditure. Mr. Kantorowicz made his first expenditure on November 16, 2015 and another shortly afterward. Moreover, the report shows the two November expenditures were made by check. That means Mr. Kantorowicz had some type of bank account open at that time. Nonetheless, he did not file a C-1 form until December 4, 2015. The failure to file the C-1 form within five days of making campaign expenditures is a violation of § 13-37-201, MCA, § 13-37-202, MCA, and § 13-37-205, MCA.

Additionally, I want to supplement my previous complaint with regard to the "Montana Christian Journal". I believe Mr. Kantorowicz violated § 13-37-216, MCA or whatever predecessor statute or administrative rule is in place setting donation limits. The amount of the undisclosed money/value Mr. Kantorowicz has received is far in excess of the \$530 limit or the committee limit.

In addition, I believe you should investigate whether Mr. Kantorowicz is engaged in illegal coordination with a political or incidental committee in violation of ARM 44.10.323(3) when he provided materials for placement in the Montana Christian Journal and/or distributed it.
