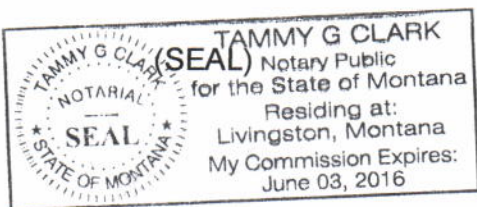

First, the two county commissioners and county planner quoted by the author of the article, Natalie Story, in fact, possibly violated the federal Hatch Act, Title 5 USC 1501. Were that true, it would seem remarkable to me that two commissioners and one planner chose not to obey their own manual and to obey federal law. Yesterday, I went to the *Enterprise* office and visited with Ms. Natalie Story, a young reporter who wrote the story in question. Ms. Story went to Park High with my youngest son. I asked her when and where she interviewed Commissioner Jim Durgan and Marty Malone and county planner, Mike Inman. She replied that she had called them at their offices in the City/County Building and that she had spoken to them in the hall while they were working. They, then, were being paid by the people of Park County in their official capacity as county commissioners and as county planner. The handbook for the Park County employees, including the Commissioners and planner, states on p. 21 under the heading, POLITICAL HEADING/HATCH ACT that "...A County officer or employee who is subject to the provision of the Hatch Act (receiving federal funds) is prohibited from engaging in the following activities: Use of his or her official authority or influence for the purpose of interfering with or affecting the result of an election or nomination for office...."

In addition, there is a Montana Attorney General opinion of January 31, 2005 in which in answer to the question, "Does Mont. Code Ann. 2-2-121 limit a public officer's or employee's right to support or oppose a political candidate or passage of a ballot issue?" The opinion of the then Montana Attorney General, Mike McGrath was "A public officer or public employee may engage in political speech so long as his or her speech does not involve the use of public time, facilities, equipment, supplies, personnel, or funds." All three, the two commissioners and planner had been interviewed by the *Enterprise* during their work day while they were on the payroll and in the Park County offices and in the hallway. I asked Ms. Story if she knew anything about the Hatch Act. She replied she did not.

Ms. Story, granted, was inexperienced, but her story should have been run by her editor who should have been aware of the law in this matter. In addition, as members of a quasi-judicial body like the Park County Commission, Commissioners Durgan and Malone have at the very least read their own handbook, known better. In fact, when the commissioners take their oath of office, they swear to uphold the law.

My second point is in line with the first. Candidate for Park County Commissioner, William Smith, has been active in advocating before the County Commission and attended a public

planning meeting along with around 200 other people most of whom were primarily ranchers who were concerned about proposed county-wide planning as a potential “taking” of private land. William Smith’s opponent Steve Caldwell said during the candidate debate in Emmigrant that he supports county planning. Part of the concern expressed by Durgan, Malone, and Inman is that William Smith sided with the Park County ranchers and was not in lock-step alliance with the commissioners and county planner Inman. This is America. There is every probability that William Smith will advocate for the people of Park County and not go along with whatever is proposed. He has demonstrated that over 30 years here, but he has always demonstrated that he will approach issues in a reasonable, intelligent manner. When I was a city commissioner, I have been at city/county meetings where the group simply quieted to hear what William Smith had to say. He brought clarity, problem solving, cooperation and reason to discussion and has earned the respect he is held in.

The third point is concern for, again, religion-baiting and the use of the almost derogatory term CUT four times by the Enterprise reporter and references going back work he had done for them in 1983---thirty years ago. I asked reporter Natalie Story if she had asked Caldwell about his faith. She said that she had not. When I asked her about her derogatory references, she replied that when she went to Park High, the kids always used that term. I remember early in my life as a civil rights advocate in Falls Church, Virginia in the early 1960’s that the “n” word was used-- - to my genuine shock as a person raised in Montana. The use of that word generally in a social situation in Virginia at the time, did not make it right. The culture of Park High at the time that the *Enterprise* reporter went there, did not justify her attitude towards those of faith expressed in the *Enterprise* article. In fact, again, the editor should have addressed that. A good friend of William Smith remarked to me that he had noticed how worn out William Smith’s Bible was. That is William’s way and this is an amazing country where we have freedom of religion---the chance to seek, evolve, and grow spiritually in the way that is best for us as individuals. You actually get to read anything you want in your search for meaning in your life. It has nothing to do with the issues facing our county commissioners as we go into the next four years. But rule of law, planning, land and water use and personal political choice does. Sometime our faith, whatever form it takes, just gets us through it all.

We have a wonderful candidate in William Smith so please vote for rule of law and fairness on November 4<sup>th</sup>. You will be glad you did.

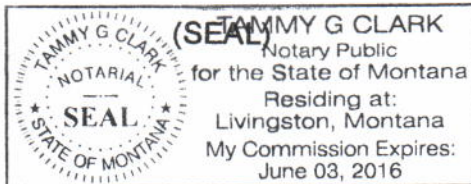

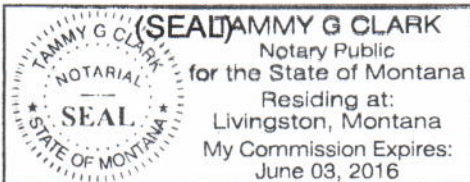
