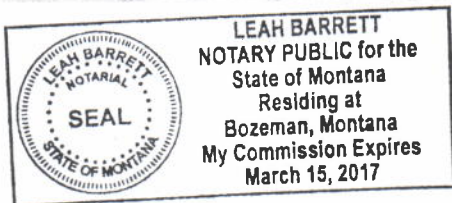

A campaign mailer sent by Rogan for Senate, P O Box 10265, Bozeman, MT 59719 by Republican candidate for Montana State Senate, Bryan Rogan, does not include the candidate's party affiliation or party symbol, as required by Montana law. The only indicator of party affiliation is "R" in parentheses on the second line of the return address. An R in parentheses is the designation used for "registered trademark," and as a party affiliation it is used only when it follows a candidate's name, not Zip Code.

A full name—Republican, Democrat, Independent, Green Party, etc.—is a party affiliation. An initial is not.

This does not comply with state statute. MCA 13-35-225 (2)

**13-35-225. Election materials not to be anonymous – statement of accuracy – notice – penalty.** (1) All communications advocating the success or defeat of a candidate, political party, or ballot issue through any broadcasting station, newspaper, magazine, outdoor advertising facility, direct mailing, poster, handbill, bumper sticker, internet website, or other form of general political advertising must clearly and conspicuously include the attribution "paid for by" followed by the name and address of the person who made or financed the expenditure for the communication. The attribution must contain:

(a) for election material financed by a candidate or a candidate's campaign finances, the name and the address of the candidate or the candidate's campaign; and

(b) for election material financed by a political committee, the name of the committee, the name of the committee treasurer, and the address of the committee or the committee treasurer.

**(2) Communications in a partisan election financed by a candidate or a political committee organized on the candidate's behalf must state the candidate's party affiliation or include the party symbol.**

**Complaints must be:**

- signed
- notarized
- delivered in person or by certified mail.
