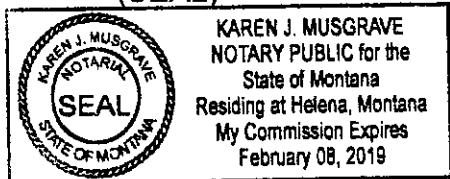

I am writing to file a complaint against Randy Pinocci for multiple violations of Montana campaign finance laws. As you know, Steve Fitzpatrick has filed a complaint against JC Kantorowicz for costs and expenditures associated with the "Montana Christian Journal" which was mailed throughout House District 19 by Randy Pinocci and JC Kantorowicz. I would also like to file a complaint against Randy Pinocci for the same violations:

1. Randy Pinocci has received contributions from undisclosed, unknown, or corporate sources in violation of § 13-35-227, MCA and/or § 13-37-217, MCA. In looking at Randy Pinocci's report, I cannot see anywhere where he reported the cost of advertising in the Journal. However, inside the Journal, there are multiple ads and candidate columns for Mr. Pinocci. The fair market value of this advertising, according to the rates sheets for the Journal attached to the Fitzpatrick complaint, has to be at least \$2,000. Moreover, the front page of the journal shows Randy Pinocci's logo which is another form of advertising.

It is also worth noting there is nothing on the report to indicate who paid for the printing or the mailing of the journal into House District 19. I believe the rough cost to mail an item of this nature is somewhere around .48 cents per piece. There are somewhere on the order of 3,000 households if one document is mailed per household. The cost of a mailing all of House District 19 is probably \$1,500. Who is paying that cost? Who is paying to print the Montana Christian Journal?

2. Randy Pinocci has violated § 13-37-229, MCA by failing to report the costs associated with advertising in the Journal, printing the journal for his use as a mailer, the cost to layout the Journal, the cost to make his ads for the Journal, the cost to mail the Journal, and the names of the people or entities who provided the funds to pay for his share of the advertising in the Journal. I believe the Journal was printed at Rivers Edge Printing in Great Falls and mailed at IPS in Great Falls.

3. Randy Pinocci has violated § 13-35-225, MCA because the Journal does not have attribution on the front page showing who is paying for the advertising on the front page where the logos are placed.

While attribution occurs on the back cover of the Montana Christian Journal that were mailed, identical magazines handed out at Cascade County Pachyderm Club, local churches and other gatherings, if they were not mailed, have no attribution whatsoever on the front and back covers.

4. Randy Pinocci has violated § 13-37-216, MCA or whatever predecessor statute sets limits on contributions by receiving donations for the Journal far in excess of the donation limit.

5. Randy Pinocci has engaged in illegal coordination by preparing materials for the Journal, preparing the Journal itself on behalf of the unknown donor, and mailing it. Pinocci has violated ARM 44.10.323. It is my understanding he paid or provided the money for the printing to Rivers Edge Printing of Great Falls.

I would ask you reference the documents contained in the complaint by Steve Fitzpatrick for additional information about rates and for a copy of the Journal itself. There is clearly something fishy with this Journal and the way Randy Pinocci and JC Kantorowicz are using it. Please, take all necessary steps to find out who is paying for the Montana Christian Journal. Thank you.
