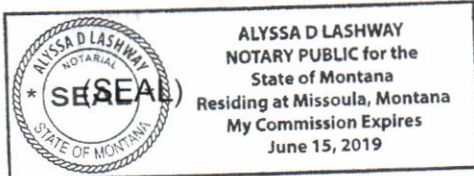

During the 2013 municipal campaign cycle, incumbent Missoula Mayor John Engen violated MCA 13-37-216 (1)(a)(iii) by accepting campaign contributions in excess of \$160 from two individuals during his bid for reelection. The City of Missoula did not hold a primary election in 2013, thus there was only one election per MCA 13-37-216 (6). Further, Engen may not have reported in-kind donations that he accepted in excess of limits established in MCA 13-37-216 (5).

Per the enclosed candidate campaign finance reports, John Engen accepted a contribution of \$160 from Brent Campbell on 3/29/2013 and another \$160 contribution from Mr. Campbell on 10/4/2013. Mr. Campbell's total contribution of \$320 was in excess of the \$160 single election contribution limit established in MCA 13-37-216 (1)(a)(iii). Further, per the enclosed Missoulian article, Mr. Campbell held a fundraiser for John Engen's reelection on 10/4/2013 with an estimated attendance of 200 people. John Engen failed to report any in-kind donations from Mr. Campbell for this campaign fundraising event, nor did Engen report any expenses for the event. Mr. Campbell is the owner and CEO of WGM Group, an engineering firm that has contracted with the City of Missoula on multiple occasions throughout Mayor Engen's time in office, to the tune of millions of dollars.

Per the enclosed campaign finance reports, John Engen accepted a campaign contribution of \$150 from Montana State Senator Cliff Larsen on 3/29/2013, and John Engen accepted another \$100 contribution from Senator Larsen on 9/4/2013. Senator Larsen's total contribution of \$250 was in excess of the \$160 single election contribution limit established in MCA 13-37-216 (1)(a)(iii).

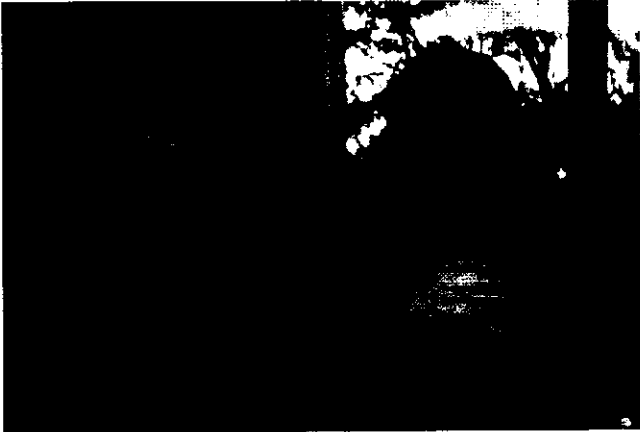

Election fundraiser for Mayor Engen brings Messina, Bullock

Homecoming weekend brings notable personalities to Missoula, and a few of them planned to gather Friday to support the re-election campaign of Mayor John Engen.

Slated to be in the mix were Jim Messina, a campaign strategist who helped President Barack Obama win re-election, and Gov. Steve Bullock. Host Brent Campbell said he's been throwing a homecoming bash for years, and some 200 people usually join his University neighborhood party.

"A lot of politicians are in town during homecoming, so it was an opportunity to get old friends together and visit," said Campbell, of WGM Group.

Campbell said the 16th annual homecoming celebration also was an opportunity to support the mayor in his quest for a third term. He said Bullock is an old friend from high school, and Messina, a University of Montana alum, planned to attend the party for half an hour.

Supporters were welcome to make donations up to \$160 to Engen's bid for re-election, but Campbell agreed the event was more about rallying in support of the mayor than filling campaign coffers. When it comes to fundraising, Engen is clearly trouncing the competition.

As of the most recent campaign finance reports, the mayor had \$16,728.99 in the bank. According to the Sept. 30 reports, his three opponents trailed: Peggy Cain, a retired nurse, had \$852.43 in the bank; Michael Hyde, an advocate for cannabis legalization, had \$242.26 left; and Dean McCollom, business consultant, had \$49.62 remaining.

Campbell said one reason Engen has been successful is he has focused on economic development, specifically launching the Missoula Economic Partnership. Since those efforts, he said, national publications such as the Kiplinger Letter have mentioned Missoula as a "hot spot" for technology.

"Missoula is on the map now finally, and we're pretty supportive of what the mayor is doing," Campbell said.

He said his home would be open to politicians for a couple of hours, and he's opened the doors to others in the past such as U.S. Sen. Jon Tester and Bullock.

"It's kind of become a little tradition," Campbell said.
