



Dear Commissioner Motl,

When Roger Hagan filed to run as a candidate for House District 19, he listed his residence address with the Secretary of State and with the Commissioner of Political Practices as 117 Gerber Road, Great Falls, Montana. That address is within HD 19 and Cascade County.

Randy and Svetlana Pinocci went to the door of 117 Gerber Road on Saturday on May 10, 2014, and asked for Roger Hagan. The young man answering the door said Roger Hagan owns the empty lots on each side of this house, but that Hagan does not live at the house. Then a young lady came to the door and stood next to the young man and said that Hagan lives in Helena.

I said, "I am Randy Pinocci and would like to talk with him"

The young man said he is Roger's son-in-law. The young lady said she is Roger's daughter.

I have been told by others that Roger Hagan lives in Helena.

It looks very much like Hagan was not truthful about his residence when he filed to run for office. If so is he still qualified for candidacy for House District 19?

I also have been told Hagan may in the past 30 days have rented an apartment in Ulm, MT, which is in HD 19 and Cascade County. If so would he be qualified to run for HD 19 if at the time of his filing his residence was in Helena?

It does seem apparent that Hagan did something wrong. Roger Hagan filed with Political Practices and the Secretary Of State with a false residence to pretend to live in the district he is running for. The question remains, have his actions crossed any legal lines for eligibility?

The voters in HD 19 have made it clear to me that it is important to know just where Roger Hagan has been living and lives currently. They want to know, does that mean where he sleeps, where he parks his car, where he pays rent, or where he pays a house payment. And, if he just recently started to rent in HD 19, but was not renting there when he filed for office, is that a legal issue for his eligibility to run for HD 19?
