The StopSetEmFreeSandefur.com Committee filed C-6 reports for the 8/28-9/26/2016 and the 9/27-10/19/2016 filing periods. (Attached) Those reports state that the Republican State Leadership Committee_Judicial Fairness Initiative Montana PAC made an inkind contribution (9/26/16 - \$43,000) and cash contributions (9/21/16 - \$50,000; 10/11/16 - \$175,000) to the StopSetEmFreeSandefur.com Committee.

The Republican State Leadership Committee_Judicial Fairness Initiative Montana PAC filed C-6 reports for the 8/28-9/26/2016 and the 9/27-10/19/2016 filing periods. (Attached) Those reports indicate that there were no expenditures made to the StopSetEmFreeSandefur.com Committee. Additionally, there is no report of any income on either of those reports, with a balance of \$238.53 shown on their latest report.

The StopSetEmFreeSandefur.com Committee 8/28-9/26/2016 C-6 reports an inkind contribution on 9/26/16 of \$43,000 for polling. This report misstates, at best, the date of receipt of the polling information. That report also shows expenditures dated 9/21/16 for website development and TV ad production also dated 9/21/16. Those campaign materials reflect the polling questions asked. The website and TV ad are based on polling that was conducted in August 2016. Notes from an individual who received the polling call in August are attached. A comparison of those notes with the website and TV ad at http://stopsetemfreesandefur.com/ reveals that the Committee received the polling information prior to the time reported by the Committee.

Political committees are required to timely report income and expenditures. Sections 13-37-225 through 13-37-231, MCA. The StopSetEmFreeSandefur.com Committee has failed to file accurate reports and is hiding the true, and only, source of their campaign funds. This is truly dark money, the committees' reports do not jive, leading to the conclusion that the true source of StopSetEmFreeSandefur.com's money has not been reported.

The only report I can find for the Republican State Leadership Committee_Judicial Fairness Initiative Montana PAC for income is the attached from OpenSecrets.org that lists the top corporate contributors to the Republican State Leadership Committee that is the parent organization of the Republican State Leadership Committee_Judicial Fairness Initiative Montana PAC. The Republican State Leadership Committee and the Republican State Leadership Committee_Judicial Fairness Initiative Montana PAC certainly know their responsibilities to report, and how to report, as they did so in 2014. (Attached)

One of the main purposes of Montana's campaign laws is to assure that the public is able to see where the money comes from and goes to in election campaigns. The Republican State Leadership Committee_Judicial Fairness Initiative Montana PAC and StopSetEmFreeSandefur.com Committee are obstructing that knowledge. The public has - no idea who is actually funding these committees. The StopSetEmFreeSandefur.com Committee should be sanctioned to the fullest extent of the law for its blatant disregard of Montana campaign laws. And, the StopSetEmFreeSandefur.com Committee should be made to disgorge the money it says it has received, and cease and desist from running any of the false and despicable TV or radio ads that it has purchased with said dark money.

they screened on likely supreme court voters-- so they are planning on a lot of drop off

they had right track, most important problem, presidential ballot with no third parties, supreme court ballot

they tested a series of traits on the candidates-- acting judge, trial experience

they tested a series of contrasting traits on the court -- too liberal, loose moral values, too anti business and positioned Juras as the balance the court needs

they tested some positives on her. they had an engaged debate where they positioned her as 30 years legal practice, distinguished law school professor, knowledge of all aspects of law like she has in bio.

they tested three negatives on her -- her opinion on public access, too close to corporations but not the legal issues, and against student free speech with the health newsletter.
