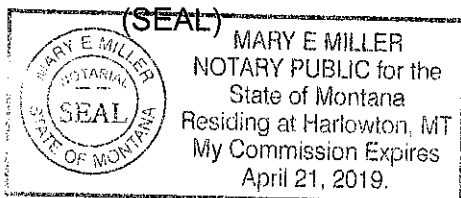

My name is Philip Wilsman. I am a resident and registered voter living in Harlowton Montana. I am not an attorney, nor do I work for, or am I campaigning for any person or persons running for any public office.

What I am is a citizen that takes his responsibilities when it comes to my vote serious. That is my sole reason in filing this complaint.

In my research of all the candidates I do not understand how candidate Hertha Lund is legally able to run for senate district 15, my district.

A candidate residing, working and voting in the district they wish to represent is a very dear and sensitive issue here in the newly assigned senate district 15. In 2014 we were assigned a rep from Cascade , Montana who had never lived, worked or voted in this district. Now , we have Ms. Lund who doesn't live, work, bank, vote or pay taxes in this district.

Her work history includes the last 5 years at Lund Law Firm and the 5 years previous at Wittich Law Firm. By her and her husband's own verbal admission she resides, works and votes in Gallatin county. This is in direct violation of the Constitution of Montana, article v Section 4 (see attached)

Not only do all the attached public documents attest to this fact, also, from the candidates own mouth during a "Meet and Greet" she put on in Harlowton on April 14, 2016 she stated the following to the full group in attendance. She said that due to her living and working in Bozeman Montana she could have chose to run for a senate seat there, but felt she was more qualified to represent a rural community due to her being raised in a rural not urban setting. That same night after the formal presentation to the public I along with a friend of mine had a discussion with the candidates husband asking questions about exactly where dose the candidate live. It was established she lives and works in Bozeman, Gallatin county. We were told by the candidates husband that "Montana lets a candidate live in a county other than the one they are running for"

## **Constitution of Montana -- Article V -- THE LEGISLATURE**

**Section 4. Qualifications.** A candidate for the legislature shall be a resident of the state for at least one year next preceding the general election. For six months next preceding the general election, he shall be a resident of the county if it contains one or more districts or of the district if it contains all or parts of more than one county.

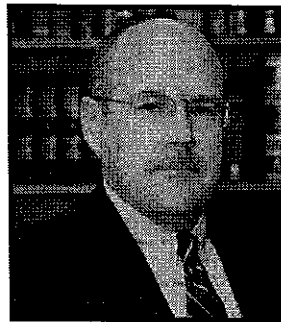

# Bozeman's Hertha Lund exits Montana Supreme Court race

HELENA -- Bozeman attorney Hertha Lund said on Wednesday that she is withdrawing from the race for Supreme Court Justice against current Justice Brian Morris.

In a statement, Lund noted the decision last week by the high court rejecting a proposed voter referendum which, if passed, would have elected judges in each of seven districts, replacing the current system of statewide elections.

"If the initiative had been on the ballot and passed, I was prepared to run a thorough campaign in Gallatin, Madison, Beaverhead and Silver Bow counties, which would have comprised the counties in the sixth district," Lund said in a news release.

"At this point, with respect to both my family life and my law practice, I would not be able to devote the proper time and energy I feel it would take to run a successful statewide race."

Lund has represented landowners against the eminent domain claims of the Montana Alberta Tie-Line, a major transmission project, and said she would continue to represent landowners on issues related to property rights.

In the race for another seat on the court, being vacated by retiring Associate Justice James C. Nelson, two of three candidates -- Great Falls attorney Elizabeth Best, Missoula attorney Ed Sheehy and Choteau District Judge Laurie McKinnon -- will advance to the November election after a June 6 primary.
