
As soon as we received notification of this oversight we immediately stopped distributing campaign materials.

You will need to add the full required attribution message to all copies of this material and email a photo to the COPP showing the attribution message added; please do so no later than the end of the day Tuesday, April 19, 2022 (2 business days from today)- per 13-35-225(6), Mont. Code Ann. COPP would also require the number of items an attribution message was added to and the date the material was distributed as part of this message.
