COPP Compliance Specialists have recently been notified that certain materials supporting your candidacy do not appear to include a 'paid for by' attribution message (see the attached photo). This material would require an attribution message of 'paid for by' with the candidate's name and address under [13-35-225](#), Mont. Code Ann. Please add the required attribution message to all copies of this material and email a photo to the COPP showing the attribution message added; please do so no later than the end of the day Thursday, March 31, 2022 (2 business days from today). COPP would request you also include the number of items an attribution message was added to as part of that message (for example: XX # of yard signs), but does not require photos of every individual item. If material is one-sided, the attribution needs to be included on the side containing the campaign message.
