
RE: Secretary of State misuse of taxpayer funds

I am writing to you deeply concerned for the “mail drop” that went to all citizens in Montana this past week. Secretary of State Christi Jacobsen constructed a postcard that implied that any random person can vote. This is blatantly untrue as only citizens ARE ALLOWED to vote. She used her Stat of Montana office and my tax dollars to align herself with the current president (including a photo) in the narrative that has been proven to be false claiming that “elections are rigged”; that “someone other than citizens are voting”.


