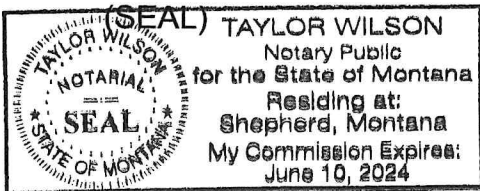

The Executive Director of Footloose Montana, Jessica L Karjala working for a 501(3)c nonprofit organization has made statements on Facebook Messenger that were categorically false and are against campaign violations rule:

1. As Executive Director of Footloose Montana, a 501(3)c has endorsed without consent or knowledge of said non-profit organization individuals running for Congressional District 2 of Montana.
2. On Facebook Messenger in messages to her friends list, she accused Ming Cabrera calling both her and Emily Harris, former campaign manager for Michael R. Cooney's gubernatorial race in two separate phone conversations as "f*cking bitches". I have no clear recollection of these conversations and what exactly was said and date that could be substantiated.
3. She said I attacked with defamatory statements Steven Held's son Jaeger Held who was still in high school at the time because Jaeger Held was chosen to be a convention delegate and Ming Cabrera wasn't. Jaeger Held was attending college at Gettysburg and I was part of a conversation regarding him not attending the 2020 Convention as a delegate and did not attend for the Joe Biden for President due to some personal circumstances regarding Jaeger Held and college.
4. A person, David Graves received a message from Jessica Karjala in which she demanded he vote for anyone else and included the statements above. Mr. Graves filled out his ballot in response and sent her a photo declaring he would not have his vote influenced by her words. She then proceeded to send several responding messages berating Mr. Graves by telling him because he voted for Ming Cabrera, she would not have supported his race for State Legislature. Further, she proceeded to tell him that she would use this information against him in the future.
5. At the time, working for the Ming Cabrera campaign as social media coordinator, a young man named Jack Milroy was making calls to possible voters and dialed her phone number unintentionally and left her voicemail. She called him back and told him he needed to leave this campaign, or she would make his life miserable for the rest of his life. Jack Milroy is for context a high school student at the time this took place during the second week of April 2024. Since his father requested that he does not want him to engage further, he told me about the threats Jessica Karjala foretold.
