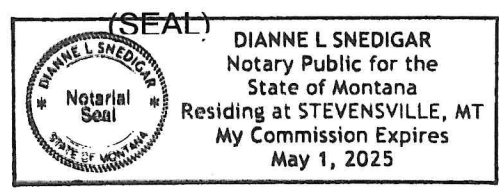

I am enclosing signs that do not have this information on them. This is a candidate for Stevensville School Board trustee for the May 2nd election.

I first saw the sign on Eastside Highway between Ambrose Creek Road and Three Mile Creek Road on Saturday, April 22nd but the highway is too busy to stop and take a picture. On Sunday, April 23rd, I saw the same sign at Kodiak Jax, 514 Main Street and CJ's Den at 324 Main Street in Stevensville and was able to take pictures which are enclosed. When candidates do this so close to an election, they know that a complaint cannot be filed in time to require that they correct it.
