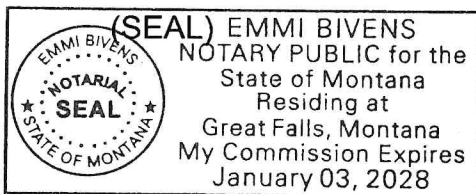

The political attribution on a billboard and on the website for Mark Winters is incomplete. The political attribution on his yard signs is also incomplete. The billboard is located around 615 Smelter Ave NE. The website is montanawinters.com. Example yard sign at 626 10th Ave S, Great Falls, nor his yard signs. Neither Mark Winter's billboard nor his website have the complete political attribution as required by Mont. Code Ann. § 13-35-225 and 44.11.601(2), ARM.

All election and electioneering communications are legally required to include attribution that identifies the entity that paid for the communication. Candidates must comply with attributions requirements.

For election materials financed by a candidate or a candidate's campaign, the attribution must include:

1. The name and address of the candidate or the name and address of the candidate's campaign;
2. In partisan elections, candidates must also state their party affiliation or include the party symbol.

* An attribution using the name of the candidate's campaign must include the first and last name of the candidate if the name of the campaign does not include at least the candidate's last name.

* Additional information, such as the name of the campaign treasurer, may be included with the attribution language, but it is not required.

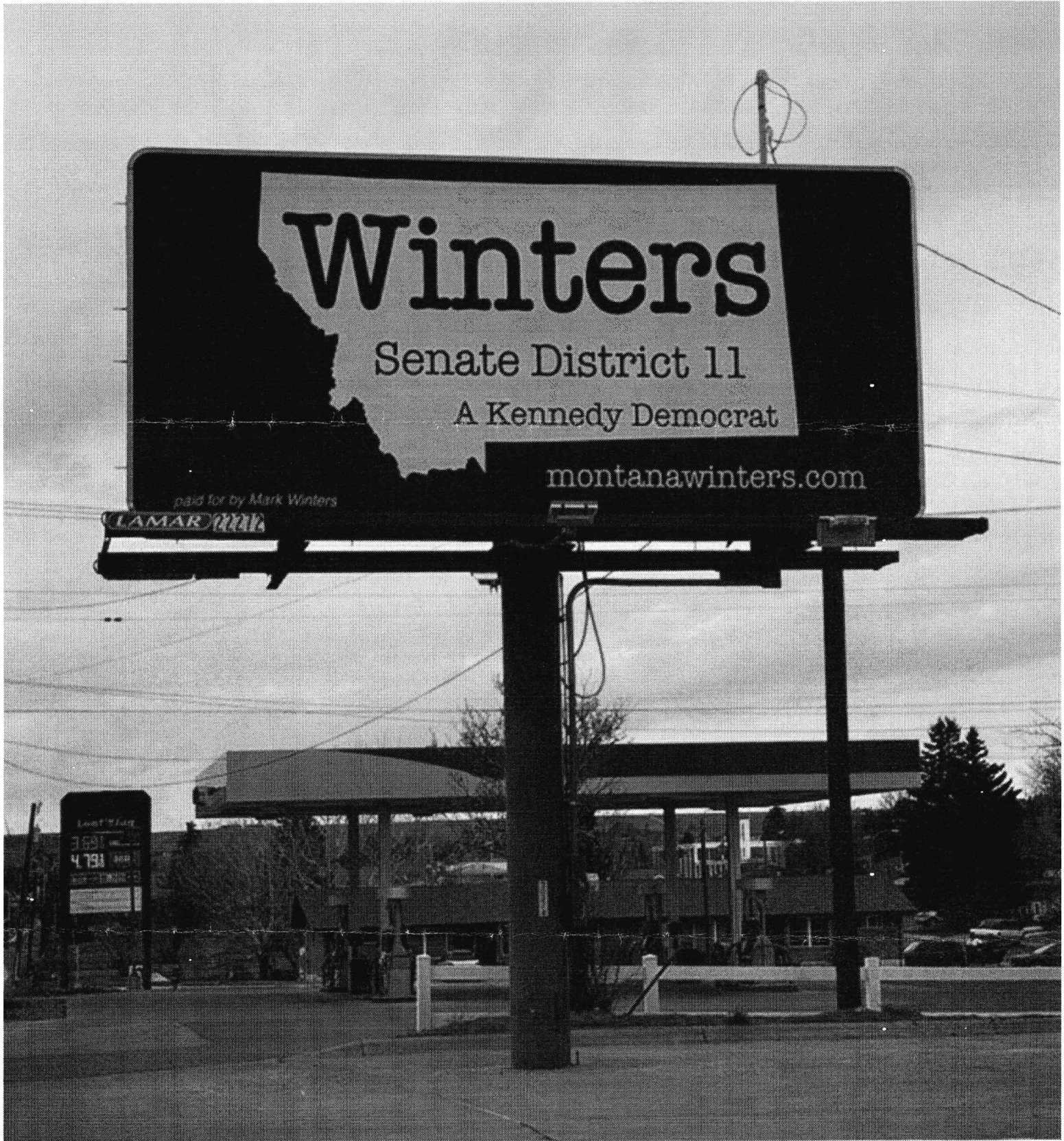


Image of billboard on 615 Smelter Ave NE, Great Falls, MT, March 2026
