The Facebook page "Melissa Smith for a Thriving Montana" has been posting content advocating for Marlee Sunchild and against the other two candidates running in the GFPS School Board election.

These posts from "Melissa Smith for a Thriving Montana" also have been advertised/"boosted" out to the community through Facebook.

Marlee Sunchild is also aware of these posts based on a comment she shared on one of the posts from "Melissa Smith for a Thriving Montana"

Some of the content is unclear who originally posted due to lacking an attribution, and has been shared on at least two Facebook accounts/pages ("Melissa Smith for a Thriving Montana" and "Jasmine Taylor for Montana"). The individuals associated with these pages have also been involved in the political process in Montana before and have familiarity with COPP rules.

Post's (original and advertisements) from "Melissa Smith for a Thriving Montana" also direct the audience to www.GFVote.com. This website based on April 21, 2024, provides a hyperlink for more information about Marlee Sunchild, but is absent any link for the other remaining candidates, suggesting a biased reporting for one specific candidate. GFVote website also lacks any attribution that may be required by COPP.

There is no record that has yet been found that would be associated with "Melissa Smith for a Thriving Montana" or GFVote. Additionally, Marlee Sunchild's CERS entries lack any financial reporting, which may be triggered if there has been >\$450 from a single source as a contribution to Sunchild's campaign.
