Thanks for reaching out. COPP confirms attribution deficiency was self-reported for campaign postcards and campaign yard signs, and has noted that in dismissing 'Violation #2' and 'Violation #3'. However, the Commissioner has accepted 'Violation #1', as the unattributed material referenced there appears to be separate from the postcards and yard signs previously addressed. For that reason, COPP requires attribution remedy as described in the Commissioner's letter be provided for that specific material.

Good Morning,

My name is Chris Fudacz with the Smarter Monforton Growth incidental committee.

We discovered an unintentional omission in material we had made. This omission was on yard signs, and also on printed material that was mailed to voters in School District 27 last week. Sometime between Friday (4/14) and Monday (4/18), active voters should have received 2,587 of the attached 'Initial Erroneous Postcards' that did not have our treasurer's information on it. Smarter Monforton Growth is a new committee that was organized in a short time frame and we were unaware that we needed to have our treasurer's information included on this material and it was a mistake. I have attached the 'Amended Postcard', which is what should have been sent out.

We also made <u>100 yard signs</u> with this same mistake. We are having everyone that we distributed signs to add our treasurer's name (Michael Nelson, Treasurer) to them. I alerted them to do this as soon as we found out that there was this omission, which most of them have already done. We are making all reasonable efforts to correct this, and sincerely apologize for our oversight.

We have not distributed anything since we learned of the mistake (4/16), and will not distribute anything that does not have our treasurer's name on it moving forward.
