Statement of Facts

On Tuesday August 19th, 2025, the Lewis and Clark Political Action Committee sent a round of paid texts to Helena voters (see No.4). The text appears to violate multiple sections of the MCA. The text provides incorrect information regarding the PAC's treasurer (MCA 13-37-204), the PAC's financial disclosures do not reflect funds that could have facilitated the cost of a large paid text (MCA 13-37-229), and those financial disclosures are well behind mandatory reporting deadlines (MCA 13-37-226).

- 1. Lewis & Clark PAC failed to adhere to the process of removing a treasurer as outlined in MCA 13-37-204.
- a. Lorna Kuney is listed as the treasurer in the texts, but Ms. Kuney has resigned as the treasurer, notifying both Lewis and Clark PAC and the Montana COPP. Their current treasurer listed on their COPP registration is Steph Jones. Their facebook page lists John Novotny as the treasurer.
- 2. Lewis & Clark PAC's financial disclosures do not reflect the funds required for even a single round of paid texts, in violation of MCA 13-37-229.
- a. Lewis and Clark PAC last submitted at C6 on 8/5/25 for the period of 04/01/2025 06/30/2025. The cash on hand reflected in C6 was \$274.81. The amount required to send paid texts far exceeds this amount.
- 3. Lewis & Clark PAC's financial disclosures are out of date, in violation of MCA 13-37-226.
- a. Lewis and Clark PAC has not submitted a C6 for the July reporting period. They should have seen an influx of several thousand dollars during this period to facilitate even a single round of paid texts.
- 4. see attachment A.
- 5. Lewis & Clark PAC has a purpose of, "To Elect Responsible Leaders for Lewis & Clark County," not to oppose bond issues.
