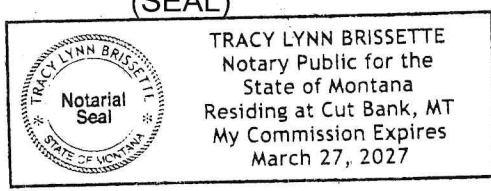

To Whom It May Concern:

I am submitting this complaint regarding the apparent failure of Matthew J Connelly, candidate for the Glacier County Coroner/Sheriff election to comply with Montana campaign finance reporting requirements.

The candidate filed a C-1A Statement of Candidate and selected the "C" box designation, which indicates the candidate is required to file C-5 campaign finance reports under Montana law and Montana Commissioner of Political Practices reporting requirements.

Despite this requirement, the candidate has apparently failed to submit the required C-5 campaign finance reports within the mandated reporting periods. These disclosures are essential to maintaining transparency and public confidence in the electoral process by informing voters of campaign contributions, expenditures, and financial activity.

Failure to file the required reports may constitute a violation of Montana campaign finance and disclosure laws. I respectfully request that this matter be reviewed to determine:

1. Whether the candidate was legally required to file C-5 reports.
2. Whether required filings were missed or remain delinquent; and
3. Whether enforcement action, penalties, or corrective measures are appropriate under applicable law.

Transparency and equal enforcement of campaign finance laws are critical to preserving public trust in local elections, particularly in offices involving public safety and public accountability.
