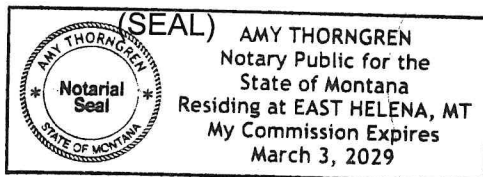

1. As of 09.03.20250, The MT Values Action Fund has not documented any fundraising or expenses for this year, and under this name, there is apparently no public record of any donations they have made to the YES! For Helena Schools committee.
Yes! For Helena Schools documented a donation from MT Values Action Fund as of 09.02.2025 for \$7,000.00. I am asking they be cited to the fullest extent for any infractions, as any individual candidate or other committee would be.
2. When seeking information on this organization, there appears to be no such entity either as "MT" or "Montana" spelled out in the state of Montana under this name or address online. On the CERS reporting site, there are several listings for this organization in "In Process", however there are no C2 filed with a treasurer or any contact information for this organization, so voters cannot learn more about them, who their donors are, what they have done in the past, or how to contact them.

This constitutes a clear lack of transparency to the public and the average voter. These systems exist to allow voters and donors to see transparency in our political elections. This is a massive disservice to the public and to the voters of Montana, and especially to the voters of Helena School District 01. Who operates this organization, where does their money come from, how can they be reached, what have they done in the past etc.?

Please process my complaint as soon as possible, and I look forward to a response from COPP.
