

#### **Background**

In January 2024, Abbey Cook, owner of Abbey Le Cook and Associates, was retained to provide political compliance services and act as Treasurer for Cora Neumann's campaign for Montana Senate District 30.

Her agreed-upon responsibilities included:

- Preparing and submitting campaign finance reports to the Montana Commissioner of Political Practices (COPP).
- Checking the campaign's P.O. Box and processing contributions.
- Setting up and depositing checks into the campaign bank account.
- Paying campaign invoices in a timely manner.
- Submitting a monthly expense report.
- Maintaining an active and accessible Google Sheet tracking campaign finances, available to campaign leadership at all times.

#### **Compensation Agreement:**

- \$1,500 startup fee (January 2024).
- \$450 per month beginning February 2024.
- Total agreed upon for February–July 2024: **\$4,200** (\$1,500 startup + 6 x \$450).

### Alleged Breaches of Service

#### 1. Invoices Not Paid on Time

- Beginning with the Montana Democratic Legislative Campaign Committee
  (MDLCC) Mansfield-Metcalf Afterparty in March 2024, invoices were frequently
  paid late.
- Vendors, including Hannah Jilk LLC and Agency Strategies, sent multiple reminders.
- Vendors threatened to discontinue services due to nonpayment, damaging the campaign's reputation.

## 2. Campaign Checks Lost or Unprocessed

- Bank statements through mid-2024 showed only seven deposits totaling \$37,090, while ActBlue records reflected \$46,847 in contributions. This gap of approximately \$9,757 does not include checks mailed directly by donors.
- In June 2024, a donor reported that their maximum contribution check had not been cashed. The donor had to reissue and resend the check.
- As Ms. Cook was responsible for monitoring the P.O. Box and deposits, the number of outstanding or lost checks remains unknown.

#### 3. Incorrect and Late COPP Filings

- On at least two occasions in 2024, COPP filings were late. Ms. Cook attributed the
  delays to COPP's system; however, other campaigns she serviced also experienced late
  filings, indicating the issue originated with her.
- When filed, reports were incomplete. Example:
  - o The report for 03/16/2024 04/15/2024 listed \$0 expenditures and \$565 in contributions, despite clear evidence of campaign spending and higher receipts.
- Regardless of system issues, Ms. Cook was responsible for ensuring filings were accurate and complete post-submission.
- These failures may have violated Montana's campaign finance reporting laws.

## 4. Failure to Provide Expense Reports and Transparency

- Despite the requirement for monthly expense reports, Ms. Cook provided only two
  reports during her six-month engagement.
- These reports were only submitted after repeated calls, texts, and emails.
- The required **Google Sheet**, intended to give campaign leadership real-time visibility, was never consistently accessible. Excuses were given instead of solutions.
- The campaign therefore lacked the ability to track cash flow, expenditures, and compliance status in real time.

#### 5. Lack of Communication

- Ms. Cook's response times to emails, calls, and texts were consistently inadequate.
- Requests for financial updates frequently went unanswered.

- Despite promising weekly updates, the campaign received only two financial summaries in six months.
- Because Ms. Cook was listed as the **primary COPP contact**, there is concern that important official correspondence may not have reached the campaign.

#### 6. Overpayment and Misuse of Campaign Funds

- By August 20, 2024, Ms. Cook had taken \$5,800 from the campaign:
  - \$3,600 in monthly retainers (8 x \$450).
  - A \$2,200 direct transfer on May 7, 2024.
- The agreed-upon total was 4,200 (\$1,500 startup + 6 x \$450).
- This left an unauthorized overpayment of \$1,600.
- On **August 20, 2024**, Ms. Cook was asked to repay the \$1,600 immediately and warned that failure to do so by **August 22, 2024** would result in a police report being filed with the Helena Police Department.
- On September 3, 2024, Cora Neumann emailed Ms. Cook requesting reconciliation of the \$2,200 May 7 transfer and confirmation of any outstanding donation checks. No satisfactory response was received.

Termination of Services - Due to repeated failures in compliance, transparency, and financial management, Abbey Cook's services were terminated on August 20, 2024.

#### **Statutory Concerns**

The above conduct may constitute violations of Montana campaign finance law, including:

- Mont. Code Ann. § 13-37-226 Timely and accurate campaign finance reporting.
- Mont. Code Ann. § 13-37-229 Duties of campaign treasurers to maintain detailed, accurate records.
- Mont. Code Ann. § 13-37-231 Prohibition against misappropriation or misuse of campaign funds.

#### **Requested Action**

We respectfully request that the Commissioner of Political Practices:

- 1. Investigate the actions of Abbey Cook in her capacity as campaign compliance officer.
- 2. Determine whether she violated Montana campaign finance statutes.
- 3. Require repayment of the unauthorized \$1,600 withdrawal (and any additional unaccounted-for funds).

4. Impose penalties as appropriate under Montana law.

#### Campaign Checks Lost

In reviewing the campaign bank account and the campaign fundraising platform *ActBlue*, it is very apparent that a number of checks have not been deposited and/or lost. For one, the bank statements to date list only seven deposits totaling approximately \$37,090. Meanwhile, the ActBlue lists contributions to date as \$46,847. This does not include donor checks outside of ActBlue.

In or around June 2024, a donor made contact to note the max out contribution check they mailed had not yet been cashed. As a result, the donor had to rewrite the check and resend it. We are only aware of this one instance due to the donor's outreach. As Abbey Cook oversaw P.O. Box and its contents at the time, it's impossible to know how many donor checks may still be outstanding or simply lost.

#### • Incorrect and Late COPP Filings:

On two occasions, COPP filings have been late. When flagged, Ms. Cook blamed the COPP system or its administrators. However, it has recently become clear after communication with other Democratic candidates that responsibility for the late filings rests with Cook, not the COPP system. Specifically, other candidates who had retained Ms. Cook's compliance services were notified that their campaign reports were late as well.

Once filed, several campaign finance reports were incomplete. For example, the report filed for the 03/16/2024 - 04/15/2024 period incorrectly lists \$0 expenditures and \$565 in contributions. It is unclear how this incomplete filing could possibly be the fault of the COPP. Even assuming an error on the COPP's end, it was Ms. Cook's job to ensure filings were complete and accurate after submission to COPP.

These oversights were not only unacceptable, but they may also have violated Montana campaign laws. In the event the campaign had a COPP complaint filed against it, it would have been due to Cook's negligence.

#### • Lack of Communication

Throughout the campaign, Ms. Cook's response times to emails, texts and phone calls were woefully inadequate. While we understand that Ms. Cook had multiple clients and responsibilities, texts and emails requesting basic information generally went unanswered. For example, we had been requesting spreadsheets and data detailing the campaign's finances for months. In the roughly six months during which Ms. Cook's services were retained, we received just two emails detailing the checks received and cash on hand. This was initially promised to the campaign as a weekly occurrence.

Finally, Ms. Cook was listed as the primary contact on all COPP campaign finance reports. During Ms. Cook's engagement, we were very concerned that important emails from outside organizations or individuals may not have been getting to the campaign. Again, this reflects poorly on the campaign and Cora, potentially harming her standing in Montana Democratic politics.

For the above-mentioned reasons, Ms. Cook's services were immediately terminated on August 20, 2024.

#### Overpayment & Funds Owed:

As of August 20, 2024, Ms. Cook had charged the campaign \$3600 (8 x \$450) plus a transfer of \$2200. This totals \$5800 for her services, but the fee agreed upon was \$1500 as a startup fee plus \$450 for 6 months (February - July) which totaled \$4200. In this case, we content that Ms. Cook took \$1600 from the campaign account without approval. *Please see the email documenting the fee agreement, which is attached to this Statement of facts.* 

As we assumed that Ms. Cook mistakenly took the \$1600, we therefore requested that it be repaid *immediately* (email communication of August 20, 2024). We further advised Ms. Cook that if payment was not remitted by the end of business on Thursday, August 22<sup>nd</sup>, we will have no choice but to file a police report with the Helena Police Department. Ms. Cook was requested to deliver to the bank or send the check via certified mail to the following address, along with email proof of mailing: PO Box 8974, Missoula, MT 59807

On September 3, 2024, Cora Neumann emailed Ms. Cook advising that the campaign was into week 2 of waiting for her reconciliation of a \$2200 transfer from the campaign account to Ms. Cook's bank account on May 7, 2024. This is documented in an attached email (Appendix). She was asked to respond with details and/or return any misdirected funds right away. Also, she was asked the status of any donation checks still to be deposited in the campaign account, as several donors reported their donations had not yet cleared.
