#### Dear Scott,

In September of 2023, as was required, I registered with the Office of Political Practices, fully aware of the law, as is my responsibility. As I was unfamiliar with the rules and laws, I conferred with the Rosebud County Elections Officer to confirm the process and ensure my obedience.

To be clear, I heard some grumblings prior to this but, considering the source and the allegations, I dismissed it as a joke. It is laughable, if not for the time and energy it is sucking out of me and your office on such a ridiculous matter. However, I should not be surprised by this, considering the history of this individual.

Having my integrity and ethics questioned publicly in such a manner is extremely concerning and degrading for me. Let's get some facts straight. At least two items stated by the accuser are incorrect. My campaign signs were purchased from UZ Marketing, 5900 Bingle Rd, Houston, TX 77092, not from the same business as his. Next, 75 signs were purchased, not 60. The invoices are attached; the total is \$389.53. Aside from these signs, no additional campaign money was spent.

When I picked up the mail today, I was shocked by what I saw. I had no idea you were attempting to get ahold of me by email. After searching, we found your November 28<sup>th</sup> resent message in our junk folder. Continuing to search, we still cannot find the first email, obviously sent November 1<sup>st</sup>. You will find no validity in your search that was initiated by a former disgruntled employee that I supervised for many years, as well as a candidate in the recent city council election who lost by a landslide.

I look forward to your written confirmation, clearing me of any campaign violations. Thank you for your help in this matter.
